

2022 SOUTHWEST FLORIDA & LEE COUNTY FAIR
ADAM BARFIELD MARKET ANIMAL YOUTH SCHOLARSHIP APPLICATION

The Adam Barfield Market Animal Youth Scholarship is sponsored by Mr. James Barfield and is administered by the Board of Trustees of the Southwest Florida and Lee County Fair Association, Inc. and is open to high school seniors who are actively exhibiting in the Market Animal Division of the Livestock Program. The Adam Barfield Scholarship Fund was established by James Barfield in memory and honor of his son, Adam, who was an Exhibitor with the Southwest Florida & Lee County Fair and showed in the Market Animal Division.

A total of \$5,000.00 for tuition is available to be awarded to two qualifying applicants in the Market Animal Division.

Annual Award Distribution: Two scholarship awards in the amount of \$2,500 each are available to be distributed for the Fall term of the year of qualifying, based on evaluation scores. Scholarship funds are paid directly to the school upon proper documentation of school registration and course selection.

Eligibility Requirements: The applicant must be an active 4H/FFA Exhibitor showing in the Market Animal Division with the Southwest Florida & Lee County Fair, hold a minimum 3.0 GPA, and be a current high school senior. This includes seniors who are concurrently dual enrolled in a college.

Application Package: Completed applications must include three letters (3) of recommendation and the students most recent semester ending report card – report card must show the students GPA. Recommendation letters should be from diverse backgrounds. Example: 4-H/FFA, School, Business, or Community Leader.

Award Criteria: *See Page 2 of application packet for specifics and clarification for each category.*

- 15% - Years, Range of entries, and accomplishments in the Market Animal Division of the Southwest Florida & Lee County Fair.
- 10% - High School Extracurricular Activities throughout High School
- 25% - Essay – 300 word minimum
- 10 % - Community Involvement and Volunteer Service – not 4-H/FFA related
- 15 % - Years and Involvement in 4-H / FFA
- 20 % - Thoroughness, completeness, and neatness of application.

Evaluation: Applications are evaluated by the Scholarship Evaluation Committee based on the criteria provided. The non-weighted GPA will be added to the score to determine final points. All decisions are final.

Due Date: **Monday, April 4, 2022.** Applications received after April 4, 2022, will be penalized two (2) points per day up to two (2) days. Applications received after April 6, 2022, will not be accepted.

Scholarship Questions for the Adam Barfield Market Animal Youth Scholarship:

Below are the required criteria to be considered for the Adam Barfield Market Animal Youth Scholarship. Information must be submitted in a typed format of your choice. The application packet should contain a maximum of (6) single-sided pages – not including the two pages of the application packet. Type should be no smaller than a 12-point font of your choice. Margins should be a minimum of ¼” on all four edges. Answers to questions, as well as pages should be numbered.

1. Provide information on your number of years, entries, and accomplishments in the **Market Animal Division** of the **Southwest Florida and Lee County Fair**. (15 points)
2. List and describe extracurricular **High School Activities** - including leadership roles, awards, and honors. Extracurricular Activities would include, but is not limited to high school clubs, high school teams, high school committees, and positions/offices held. (10 points)
3. **Essay** – 300 word minimum - write an essay about yourself, your experiences, and accomplishments, **in the Market Animal Division**, at the **Southwest Florida & Lee County Fair**, your educational plans, and career goals. **Essay must be related to this specific scholarship (25 points). A maximum of 10 points will be deducted if the essays are ‘copied’ and do NOT meet this criteria.**
4. List and describe any **community wide involvement** (civic clubs, church, etc) and years involved in each – this should include a minimum of ten (10) hours of community volunteer service, **not 4-H or school related. (10 points)**
5. Describe your involvement, specifically, in your **4-H/FFA Club**, include number of years, positions/offices, etc. (15 points)
6. Thoroughness, completeness, and neatness of application. This includes proper grammar, punctuation, and following directions. (20 points)

Applications received after the April 4, 2022, will be penalized two (2) points per day up to two (2) days. Applications received after the April 6, 2022, will not be accepted.

I understand it is my responsibility to confirm all required paperwork is received by the Southwest Florida and Lee County Fair Association, Inc. I hereby affirm that I meet the eligibility requirements for the Adam Barfield Youth Scholarship and hereby formally request consideration of my application by the Scholarship Review Committee.

The Scholarship Review Committee of the Southwest Florida and Lee County Fair Association, Inc. has my permission to review the academic records I have submitted in support of my application for this scholarship.

Funds may be expended for class books after all educationally related costs have been paid for each semester. If the scholarship funds are not used for the Fall Term specified, the circumstances must be reviewed by the Board of Trustees and their decision is final.
